Local Government Observers

Criminal Justice Council Created

The LWV of the Mid-Hudson Region has promoted the formation of a Criminal Justice Council as a result of our study of the criminal justice system in Ulster County. The County Legislature adopted this idea in the spring and has now appointed 19 of the 21 members who will form this Justice Council. The make-up of the council comprises decision makers from the following agencies: Public Defender, District Attorney, Corrections (Jail), Youth Bureau, Probation, County Court, Mental Health, Sheriff's Department, Department of Social Services, Drug Court, community Corrections, and Alternative Sentencing. In addition, there will be seven civilian representatives: Richard Barnhart, Catherine McCaffrey, Roger Rascoe, Eve Waltermaurer PhD., David Singer, Patrick Sheehan, Thomas P. Kadgen (an LWV member). The final appointments are awaiting nominations from the Magistrates Association and the Bar Association.

At the recent legislative session, Minority Leader Donald Davidson thanked the LWV for all of the work that went into introducing and advocating for this initiative, which he said was long needed.

The Criminal Justice/Public Safety/DWI committee should appoint a Council chair early in October.

Voting Machine Selection

In case you missed it, the following letter appeared in both the Kingston Freeman and the Poughkeepsie Journal. Additional efforts you can make are to contact your Board of Elections and keep the pressure on.

Dear Editor,

The League of Women Voters of New York State has endorsed the use of paper ballot precinct based **optical scan** voting systems because they best meet League criteria of security, accuracy, recountability and accessibility.

Optical scan voting systems have been used in the U. S. in elections for twenty years and were used in 46% of counties, 36% of precincts, and by 35% of registered voters in the 2004 election, according to Election Data Services. In the future, seven states will use optical scan exclusively and thirty-seven will use it as part of mixed systems of voting to meet HAVA (Help America Vote Act) requirements. The technology is tested and proven, contrary to that of DREs (direct recording electronic systems) which lack transparency, and are not fully equipped and certified with disabled accessibility and voter verification features.

We hope that the Ulster County Board of Elections will consider this recommendation when they make their critical decision on replacing the current lever voting machines with new voting systems as prescribed by law.

Barbara Bartoletti

Barbara Bartoletti has been the Legislative Director for the League of Women Voters of New York State since 1988 and lectures statewide on advocacy/issues and citizen participation in government. She also does political commentary for *Channel 9 News* in the Capital Region and writes a column for the *Post Standard* newspaper in Syracuse, New York. Barbara has also presented at conferences and led workshop training in advocacy, media relations, and coalition building in Russia and Armenia. Her community involvement extends to organizations such as the Council of Community Services, Family Planning Advocates of New York State, League of Women Voters of Albany County, Center for Women in Government, and Public Schools for the 21st Century (PS21).

Readers will know Barbara's column "Inside Albany," which reports on the actions and inaction of the state legislators and some of their political maneuvering. Her insightful reporting and witty presentation give members a good picture of what's going on at the state level, and what the state League is lobbying for.

Always an interesting and dynamic speaker, as well as a very well-informed lobbyist, Barbara is invaluable to local leagues in helping them understand what to do and how to do it to influence our state government.

This year, there are many challenges for the state: new voting requirements and machines, the effects of Hurricane Katrina on energy supplies, response to the human needs of evacuees, and how to establish equitable school funding.



General Meeting October 18

October 18th will be our next general meeting. The topic will be "Issues and Advocacy, and our speaker will be Barbara Bartoletti, the Legislative Director for the League of Women Voters of New York State.

You will have an opportunity to hear what the issues are on the state level, and what League stands are on them. You will hear about recent achievements of the league's and efforts that are continuing.

Another part of the meeting will be devoted to more local concerns, such as county-wide initiatives and proposals. Both parts of the meeting should do much to help us all be informed citizens.

The meeting starts at 7:00 PM and ends at 9:00 PM. The church is on Sawkill Road in Kingston. From Washington Avenue in Kingston, turn on to Sawkill Road between the Mobil and Citgo gas stations. The church is on the right. From the thruway, Washington Avenue is the second exit from the traffic circle. Turn left on Sawkill Road. See the website for detailed directions.

First Membership Mixer

The approximately seventy members of the LWV and their guests who attended the first ever membership mixer at the Wiltwyck Golf Club on September 15th all left smiling despite the threatening weather. And they had reason to: the delicious food was plentiful, the welcoming drinks were bountiful, and the camaraderie was wonderful. As for the program, the remarks by the president of the New York State League were masterful. Ms. Merrins recounted what the League is and does in her informal and humorous manner. She emphasized what the League does for members in terms of making them feel involved and useful, and what the members do for the League and for the government. Being part of the League is personally fulfilling and socially useful. Ms. Merrins also gave a critique of the two types of voting machines which by law (Help America Vote Act) must replace our old lever machines by Election Day 2006. Failure to comply could result in the forfeiture of some of the federal funds provided to effect the change. In New York State, each county Board of Elections must select either a paper-based optical scanner or an ATM-style machine (DRE). The League of Women Voters unequivocally favors the optical scanners which are simpler, cheaper to maintain, and provide easier verification in the event that a recount is needed. Ms. Merrins urged people to keep the pressure on the Board of Elections. On page 3 of this issue, you will see a copy of a letter that our league wrote to local newspapers urging adoption of optical scan machines. Members may want to use this as a model for their communications.

Mention must be made of the intrepid souls for Dutchess County who defied not only the weather, which turned out to be a non-issue) and arrived despite a 45-minute backup on the Mid-Hudson Bridge. We were also honored by the co-presidents of the Saugerties League of Women Voters, and by Martha Kennedy, the Vice-President for Membership of the NYS LWV. Ms. Kennedy accompanied Ms. Merrins. The mixer was a success and attracted a number of non-members who we hope will become members soon. Thanks go to the Program Committee for a job well-done in a very short time. Ms. Merrins brought enthusiasm and expertise and we look forward to seeing her again.

Yard Sale Results

Not all of the results are in from the yard sale as yet. Sunday was completely rained out, so there are many things still in the basement. Some will go to other yard sales, some may go to Katrina relief, and some may wait for next year's yard sale (assuming we have one). Lee Cane's calling for donations and baked goods has always brought in easy money (easy for those who don't make the calls!) and people were generous this year. Before expenses, we took in about \$2000 (in one day!). Thanks to all who worked so hard on the sale.

Financing Education

There is a statewide study to update the league position on financing education, in which all local leagues are encouraged to participate. The state league will provide a central library on its website for references, study questions and the list of contact people from local leagues who are involved with the study. Materials such as centrally prepared DVDs will be used to facilitate research of the study questions.

So far, there have been three meetings to set the scope of the study and to explore its feasibility within the one-year time frame. Leaders have been chosen for the three elements of the study: gambling (Nancy Kleintop of Rochester), charter schools (Lee Tektowski of Buffalo and Betsey Swan of Albany) and School Taxpayer Relief Program (STAR) (Marian Bott of NYC.) Joan Johnson (Syracuse), Lenore Banks (Buffalo/Niagara), Joan Photiadis (Buffalo/ Niagara), Lorraine Newman (East Nassau), Barbara Bartoletti (Renssalaer), Joan Elliott (Schenectady), Carol Oestrich (Broome/ Tioga) and Pat McGowan Webb (Albany) have joined the statewide team.

Regional meetings will be held for interested leagues to learn more and decide on participation in the study.

The League supported the plaintiffs in the Campaign for Fiscal Equity law suit, and supports widening the CFE remedy to the whole state, not just New York City. The current study will address the question of who will pay for a more equitable education system, looking at potential revenue sources, evaluating them with respect to the volume of revenues generated, fairness from the standpoint of the relationship the revenue measure has the ability to pay, stability, and impact on the business climate. Charter

school impact on school finance, gambling revenues as a source of financing, and the impact of STAR will also be looked at.

LWVNY will send out bibliographies of the areas of studies, and plans to make videos of interviews with experts and panel discussions for local distribution. There will also be a booklet to assist in the consensus process.

Our league has not yet undertaken to participate in the study, but if there are people interested in being part of it, please let Chris Henning know (339-0509). Obviously, it is of great importance to our future to have good schools, supported in an equitable and affordable manner. Our local study pointed out the need for better communication between the educational authorities and the general community.

For more information about the Campaign for Fiscal Equity and the litigation, there is a website, www.cfequity.org which has a history, a summary of the relief ordered by the court, and other background and status information.

Consensus on STAR and ways to finance the CFE remedy is scheduled for April 2006. Consensus on charter schools and the appropriateness of gambling proceeds to fund education is scheduled for November, 2006.

Our local study on gambling resulted in a consensus that gambling was not a healthy or effective way to provide financial stability and that the social harm outweighed any benefits. In the light of the state's financial woes and the need to spend a great deal more money on schools, this study needs to be revisited and updated, which we can do as part of the state study.

Please sign up!

Logging on to National LWV Web Site

First you need a personal username and password, which is a three-step process.

Step One Pre-Register: go to <http://www.lwv.org/PreRegister> and fill out the form. If the League has your email address, only fill in the first three fields. If it doesn't, fill in all six fields. *NOTE: Do Not Hit the "Enter" key. Use the "Tab" key or use your mouse to move to the next field. When finished, hit "Submit."*

An email will be sent to you that will contain your temporary or initial password. *If you don't receive it within 10 minutes, check your spam folder.*

Step Two Login and set your password.:

Follow the link in the email to the [LWV Online System](#) page and complete your registration and set your own personal password. You will need the email address and the initial password in the email. The system **IS** case-sensitive, so it is ***easiest to cut and paste the password directly from the email into the field.***

Step Three Login to the lwv.org website.

When you log in to the LWV Online System, look to the left of the page. You will see a navigation menu. The second item from the bottom is "Change Password." Click here and paste the password from the email into the "current" field and then enter your chosen password in the fields below. **Your new password should be 8 characters long.** Remember to hit "submit."
