- The Ten Percent Challenge, a framework to hasten the implementation of energy efficiency and renewables and draw attention to the Hudson Valley as a clean energy corridor.

Villeneuve, Director of NYSERDA's Residential Efficiency and Affordability Program, with case studies from Towns of Bedford and Babylon. Explanation of a new NYS municipal loan program, also know as Property-Assessed Clean Energy (PACE), by which municipalities can pass legislation to help property owners fund energy efficiency measures and/or renewable energy infrastructure -- and the cost is repaid on the owner's tax bills. Will also address contractor certification, retrofit ramp-up and American Recovery and Reinvestment Act (ARRA) stimulus funding.
